## Context

- Terms of Reference for Quotas Allocation Subcommittee revised to reflect:
  - Planned FM and specialty increases as mandated by government
  - Existence of new Needs-based physician requirements model from the MOHLTC and the OMA
  - Existence of new CaRMS matches for Medical Subspecialties and Pediatric Subspecialties
  - New Mississauga training sites and Toronto Integrated Medical Education initiative.
- Programs surveyed in June 2011 for Quota requests
- QA Subcommittee met September 6, 2011 to review proposals and quotas for:
  - PGY1 entry (IMGs and CMGs) for March 2012 CaRMS match
  - Medical Subspecialty for November 2011 CaRMS match
  - Pediatric Subspecialty (took place June 2011)
  - FM PGY3
  - Surgical Subspecialty Quotas.



#### Survey Results

#### **Quotas Survey Results**

PGY1:

- Increases in PGY1 positions sought in Core Internal Medicine (3), Dermatology (1) and Vascular Surgery (2)
- > Vascular Surgery is a new PGY1 Entry program as of 2012.
- > Other PGY1 entry programs are seeking status quo on CMG intake for 2012
- > Family Medicine is adding 9 which completes their Phase 2 Expansion
- On IMG intake, Psychiatry is seeking an increase of 1, Vascular Surgery seeking 1 and General Surgery decreasing by 1
- Net specialty quota for CMGs increased by 6 and FM quota increased by 9 for total expansion of 15 positions: **346 CMG positions**
- Net increase in IMG quota by 1: 68 CMG positions (24 FM and 44 spec)
