Background

- Residency Allocations Subcommittee reconstituted in Spring 2025 with updated membership and refreshed guiding principles
- Subcommittee met in June and July to review results of annual allocation survey of PGY1 entry and subspecialty programs for MOH funded positions
- Recommended allocations made based on guiding principles and PGME expansion priorities (Scarborough, Mississauga and Central Simcoe)
- Recommendations on Family Medicine expansion for 2026 pending negotiations with government on capital and operating resources to support expansion.
- As of July 2025
 - 25 of 27 PGY1 RC expansion positions added (2 remain)
 - 26 of 40 PGY1 FM expansion positions added (14 remain)
 - 370 CMG/87 IMG positions offered in PGY1 match (457 total)
