


 - 14 Programs APOR (Action Plan Outcome Report)
 - 4 Programs ER (External Review)
 - 3 Programs NOI (External Review)
 - 1 Institution APOR (Action Plan Outcome Report)

Internal Review Committee

- Requested Internal Reviews for all Programs with follow-up by External Review
- Continuing Review of action plans for all Programs with follow-up by APOR
 - 3 internal reviews
 - 5 resident reports
 - 3 program administrator reports
 - 3 IRC Learning Environment Follow-up
- Review Institutional Action Plan next meeting

Learner Mistreatment AFI - Institution

- **4.1.4.4:** The postgraduate office has an effective mechanism for addressing and reporting instances of mistreatment (Institutional Standards)
- Reviewers acknowledged that system was in development but not fully implemented at time of review in November 2020.
- Requested follow-up by Action Plan Outcome Report in November 2023.

Learner Mistreatment Institution Action Plan

- Development of Office of Learner Experience
- Guideline for Managing Disclosure about Learner Mistreatment
- Learner Mistreatment webpage for discussions, disclosures and reporting
- Monitoring and reporting through Office of Learner Experience Annual report and VotR surveys
- Full action plan to be reviewed by IRC and then PGMEAC
