Internal Review Committee

As a subcommittee of the Postgraduate Medical Education Advisory Committee (PGMEAC) for the University of Toronto, Temerty Faculty of Medicine, the Internal Review Committee (IRC) oversees accreditation activities for all residency programs. This includes Family Medicine and Areas of Focused Competence (AFC) diploma programs, which are monitored according to RCPSC and CFPC standards of accreditation. The Internal Review Committee also undergoes a Quality Improvement review at the end of each accreditation cycle to ensure the process remains relevant and useful. Timelines – What's coming next

- Programs will begin to submit their Draft APOR's to the PGME office in October 2022 for review. The final versions are due to the RCPSC/CFPC by November 30, 2023.
- Programs that have an outcome of external review, will have their internal reviews commencing in October 2022 – November 2022. The IRC will review their internal review reports beginning December 2022.
- Royal College will conduct external reviews by November 2023.
- The PGME office will begin organizing internal reviews of programs with follow-up at regular cycle in 2024-2026.
- The next accreditation on-site survey will take place in November 2028.

The PGME Accreditation Team will continue to work with programs throughout each process. Workshops will be organized for PAs and PDs to support their program's needs. The Accreditation Team will meet with programs on request to review AFI's, discuss APOR's, accreditation questionnaires or assist with any questions with regards to the process. The PGME Assessment Team is also available to review ITERS/ITARS and other assessment needs of programs.



Areas of Focus Competence (AFC) Programs

The Royal College of Physicians and Surgeons of Canada has established national standards for evaluating and accrediting Canadian Areas of Focused Competence (AFC) programs. Currently, at the University of Toronto, we have 11 accredited AFC programs.
