Timelines – What's coming next

- Programs have begun to submit Draft Action Plan Outcome Reports (APOR's) to the PGME office for review. The final versions are due to the RCPSC/CFPC by November 30, 2023.
- Programs with an outcome of external review, have begun internal reviews.
- The PGME office has begun to review Internal Review reports.



- Royal College will conduct external reviews by November 2023.
- The PGME office will begin organizing internal reviews of programs with follow-up at regular cycle in 2024-2026.
- The next accreditation on-site survey will take place November 2028.
