1. AGENDA/MINUTES

- a) M. Giuliani welcomed members and provided a brief roll-call of representatives at today's meeting. The agenda was approved as written.

3. NEW BUSINESS

a. Resident Experience Study (see attachment)

P. Rowland discussed a qualitative research Study: Experiences of redeployment: A qualitative study with medical residents at University of Toronto. The aim of this study is to understand residents' experiences of redeployment during the COVID-19 pandemic. With particular interest in how experiences of redeployment have impacted the way they think about their profession and about the places where they work.

c. MBA Program with Healthcare Management (see attachment)

B. Golden and S. Park introduced the MBA program offered through Rotman. This program is designed for mid-career professionals from industry, care providers, service delivery organizations, consulting firms, public agencies, the sciences and payers in the healthcare and life sciences sectors around the world. P. Abdool introduced her role as the new Chair of SEAC. Her recent environmental scan includes:

- Various ways these themes can be achieved
- Restart SIM City Rounds
- Potential barriers

e. Resident Update

H. Aljazzaf provided an update on PARO activities:

RDAW Successes

- Over 200 e-cards were distributed to residents, with really positive feedback from those who
 received them. Sweet messages were shared, a lot of people reached out to say they liked being
 able to thank co-residents.
- Residents enjoyed treats at 12 different hospitals.
- Ripley's Jazz Night social to end off the appreciation week oversold, with a total of 69 residents attending.

PARO and PGME Facilities Survey

The follow up survey to hospital sites will be sent out in March to check for improvement with access to healthy food, and to survey resident's access to Wi-Fi.

PARO is holding the first in-person Full General Council meeting on March 10th since pre-pandemic. During the meeting, elections will be held for the President and Treasurer elect. Elections for other positions will be held in July.

The new Healthy Food Initiative at UHN was discussed at our most recent General Council meeting. Residents were happy to hear that there has been some progress on this initiative. Some feedback was shared that quantities seemed to be low and supplies didn't seem to be replenished throughout the day. GC reps shared that there has been a similar pilot at Sick Kids, that has been running successfully.

f. **AFC New Approved Programs** (see attachment)

L. Murgaski gave an update on the new AFC approved programs that are accredited and go through a full accreditation cycle. AFCs are equivalent to one to two years of additional training in highly focused areas of practice that may otherwise be considered for recognition as a subspecialty. Two new programs have recently been accredited: Acute Point-of-Care Ultrasonography and Solid Organ Transplantation.

g. **MD EPA Pilot** (see attachment)

C. Abrahams and A. Punnett shared about the implementation of workplace-based assessments in the MD program. The AFMC has mandated that 12 general EPAs be completed by medical students before graduation. These are not used to determine progress decisions but to provide informative feedback during an assessment period. Core EPAs have been developed for each course, conversations will be documented and will involve coaching. This allows the UME program to have consistent workplace-based assessments across the clerkship period. Assessments will be completed by both faculty and PG trainees. Full implementation will start in September 2023, with a pilot launched in mid-March 2023. Complete details of the process and the EPAs can be found in the attached slides.

h. MEITT Introduction

- J. Dare shared information about a new project undertaken within Medical Education: Medical Education Information Technology Transformation (MEITT) will transform existing legacy systems (core and ancillary systems related to Power/MEDSIS) and IT system fragmentation to a fully functional system(s). Goals include:
- Engage stakeholders across the medical education continuum
- Recommend quality improvements in IT infrastructural streamlining and sustainability
- Alignment between MD Program and PGME
- Maintain transparency through communication about project plans and development
